Bylaw No. 3701/2023

Being a bylaw of the City of Red Deer, in the Province of Alberta, to regulate the use of Highways in the City, regulate safe interaction between pedestrian and vehicular traffic and parking on publicly-accessible private property;

WHEREAS, pursuant to section 7 of the Municipal Government Act, RSA 2000 c M-26 (MGA), a council may pass bylaws for municipal purposes respecting:

- (a) the safety, health and welfare of people and the protection of people and property;
- (b) people, activities and things in, on or near a public place or place that is open to the public;
- (c) transport and transportation systems; and
- (d) the enforcement of bylaws;

AND WHEREAS the *Traffic Safety Act*, RSA 2000, c T-6, empowers a Council to regulate and control Vehicles, animal and pedestrian traffic and parking on Highways and other property within the municipality;

AND WHEREAS the Off-Highway Vehicle Act, RSA 2000, c O-5, empowers a Council to regulate Off-Highway Vehicles along Highways within the municipality's care and control.

NOW THEREFORE COUNCIL OF THE CITY OF RED DEER ENACTS AS FOLLOWS:

Part I – Title and Definitions

Short Title

I This bylaw may be referred to as the "Traffic Bylaw".

Definitions

- In this Bylaw the following definitions shall apply:
 - (a) "Alley" means a narrow Highway intended chiefly to give access to the rear of buildings and parcels of land;
 - (b) "Boulevard" means a part of a Highway in an urban area that:
 - (i) is not a Roadway, and
 - (ii) is a part of the Sidewalk not especially adapted to the use of, or ordinarily used by, pedestrians;
 - (c) "City" means the City of Red Deer municipal corporation;

- (d) "Commercial Vehicle" means a Vehicle requiring a safety fitness or operating authority certificate from the Registrar, pursuant to the Alberta Commercial Vehicle Certificate and Insurance Regulation, AR 314/2002, as amended;
- (e) "**E-Scooter**" means a Motor Vehicle that:
 - (i) has a permit to operate granted by the province of Alberta;
 - (ii) has steering handlebars;
 - (iii) consists of a footboard mounted on two or three wheels; and
 - (iv) while capable of being propelled by muscular power, may be propelled by one or more electric motors;
- (f) "Emergency Vehicle" means:
 - (i) a Vehicle operated by the RCMP, a police service or a Peace Officer;
 - (ii) a fire-fighting or other type of Vehicle operated by the fire protection service;
 - (iii) an ambulance operated by a person or organization providing ambulance services.
 - (iv) a Vehicle operated as a gas disconnection unit of a public utility, or
 - (v) a Vehicle designated as an emergency response unit by the City Manager;
- (g) "Heavy Vehicle" means a Vehicle exceeding:
 - (i) 12.5 metres in length; or
 - (ii) 8,000 kilograms, actual or registered weight;

but does not include a Holiday Trailer or Recreation Vehicle.

- (h) "Highway" means any thoroughfare, street, road, trail, avenue, parkway, driveway, viaduct, lane, Alley, square, bridge, causeway, trestleway or other place or any part of any of them, whether publicly or privately owned, that the public is ordinarily entitled or permitted to use for the passage or parking of Vehicles and includes:
 - (i) a Sidewalk or Boulevard;
 - (ii) if a ditch lies adjacent to and parallel with the Roadway, the ditch; and
 - (iii) if a Highway right of way is contained between fences or between a fence and one side of the Roadway, all the land between the fences, or all the land between the fence and the edge of the Roadway, as the case may be;
- (i) "Hoarding" means a protective fence erected around a building site designed to contain construction activities and limit the escape of construction debris;
- (j) "Holiday Trailer" means:
 - (i) a Trailer designated, constructed, and equipped as a permanent or temporary dwelling or sleeping place; or
 - (ii) any structure designated, constructed and equipped as a permanent or temporary dwelling or sleeping place and intended or capable of being loaded onto or carried upon a Motor Vehicle or Trailer;

- (k) "Leisure Vehicle" means a bicycle, an electric bicycle, roller skates, in-line skates, a skateboard, a scooter, an E-Scooter, or other similar Vehicle.
- (I) "Loading Zone" means a portion of a Highway marked with a Traffic Control Device for parking Vehicles while actively loading and unloading;
- (m) "Motor Vehicle" has the same meaning as in Alberta's *Traffic Safety Act* and related regulations, as amended, but does not include an electric scooter, electric bicycle, or electric personal assistive mobility device;
- (n) "Municipal Tag" means a document alleging an offence issued pursuant to the authority of this bylaw;
- (o) "Off-Highway Vehicle" has the same meaning as in the *Traffic Safety Act* and related Regulations, as amended;
- (p) "Over-dimensional Vehicle" means any Vehicle requiring an overdimensional permit as defined in Alberta Regulation 315/2002 the Commercial Vehicle Dimension and Weight Regulation, as amended;
- (q) "Park" means any property, whether developed or not, owned, controlled or maintained by the City that is:
 - (i) preserved as a natural area;
 - (ii) intended to be used by the public for recreation and general enjoyment including, but not limited to, open fields, sports fields, playgrounds, picnic areas, trails, ponds, community gardens, plazas, squares and promenades;
 - (iii) zoned "A1" (Future Urban Development District), "P1" (Park and Recreation District), "A2" (Environmental Protection District), or "PS" (Public Service District) pursuant to the Land Use Bylaw;
 - (iv) designated as an environmental reserve, municipal reserve, school reserve, municipal and school reserve, conservation reserve or public utility lot pursuant to the Land Use Bylaw; or
 - (v) a cemetery;
- (r) "Parking Session" means the timeframe by the operator of a Vehicle for the anticipated duration they will be parked in a marked stall, whether on street, City parking lot or Parkade;
- (s) "Parking Zone" means the areas marked by a specified parking time restriction;
- (t) "Parking Subzone" means the identified sections within a Parking Zone on a Roadway or City block;

- (u) "Peace Officer" means a bylaw enforcement officer, community peace officer or a member of the Royal Canadian Mounted Police;
- (v) "Playground Zone" means that portion of a Highway identified as a Playground Zone by a Traffic Control Device;
- (w) "Public Facility" means any building, structure or facility owned, controlled or maintained by the City including, but not limited to, administrative buildings, City operations or workplace centres, emergency response stations, multi-purpose centers, swimming pools, playgrounds, picnic shelters, washrooms, golf courses, museums, libraries, sports venues, performing arts venues, parkades, parking lots, Transit Terminals, community or activity shelters, as well as the property, grounds and parking areas ancillary thereto;
- "Public Passenger Vehicle" means a Commercial Vehicle used for transporting passengers;
- (y) "Recreation Vehicle" means a Motor Vehicle designed, constructed, modified, or equipped as a temporary dwelling place, living abode, or sleeping place, but does not include a truck tractor unit;
- (z) "RPP Zone" means a residential parking program zone requiring a permit to overstay the posted time restriction;
- (aa) "Roadway" means that part of a Highway intended for use by vehicular traffic;
- (bb) "Rules of Use" means regulations, terms or conditions governing the use of a public area or public transit Vehicle, as prescribed by the City Manager;
- (cc) "School Zone" means that portion of a Highway identified as a School Zone by a Traffic Control Device;
- (dd) "**Short-Term Parking**" means parking provided on a Highway or City-owned parkade or parking lot, here payment is required on an hourly or daily basis;
- (ee) "Sidewalk" means that part of a Highway especially adapted to the use of, or ordinarily used by, pedestrians and that part of a Highway between
 - (i) the curb line, or
 - (ii) where there is no curb line, the edge of the Roadway, and the adjacent property line, whether or not it is paved or improved;
- (ff) "Slow Moving Vehicle" means:
 - (i) an animal or an animal-drawn Vehicle;
 - (ii) a piece of machinery or equipment designed for use at speeds not exceeding 40 kilometres per hour; or

- (iii) any Motor Vehicle traveling substantially less than the normal speed of the traffic on the Highway at that time and place and under the conditions than existing;
- (gg) "**Special Event**" means an event for which a Special Event Permit is granted pursuant to the Special Event Bylaw;
- (hh) "**Traffic Control Device**" means any sign, signal, marking or device placed, marked or erected under the authority of the *Traffic Safety Act*, as amended, for the purpose of regulating, warning or guiding traffic;
- (ii) "Trailer" means a Vehicle designed to be attached to or drawn by a Motor Vehicle;
- (jj) "Transit Terminal" means an area intended exclusively for use by public transit Vehicles to allow passengers to embark and disembark and for use by passengers awaiting rides on public transit;
- (kk) "**Vehicle**" means a device in, on or by which a person or thing may be transported or drawn on a Highway and includes a combination of Vehicles but does not include a mobility aid;
- (II) "Vehicle for Hire" means a Vehicle used or offered for the transportation of at least one passenger in return for compensation from any place within the City to a destination either within or outside of the City, pursuant to the Vehicle for Hire Bylaw; and
- (mm) "Windrow" means the linear ridge or pile of snow left behind after snow plowing equipment passes by.

Part II - Vehicle Operation

Traffic Control Devices

- A person operating a Vehicle on a Highway must comply with direction from a Traffic Control Device.
- 4 No person, other than a City employee or Peace Officer performing the duties of that role, shall tear down, remove or interfere with any Traffic Control Device, barricade, flare or other thing placed in accordance with the *Traffic Safety Act* or this bylaw.

Speed Limits

- The maximum speed limit is 50 kilometers per hour unless otherwise indicated by a Traffic Control Device or this bylaw.
- **6** Despite section 5 and unless otherwise indicated by a Traffic Control Device or this bylaw, the maximum speed limit is:

- (a) 20 kilometers per hour in an Alley;
- (b) 30 kilometers per hour within a School Zone between the hours of 8:00 am and 4:30 pm on a day when school is in session; and
- (c) 30 kilometers per hour within a Playground Zone between the hours of 8:00 am and 9:00 pm.

Restricted Highway

- A Highway, or portion of it, may be restricted to a particular class of Vehicle including, but not limited to:
 - (a) buses;
 - (b) school buses;
 - (c) taxis;
 - (d) bicycles; or
 - (e) a combination of Vehicle classes.
- When a Highway, or portion of it, is restricted for use to a particular class of Vehicle, only that particular class of Vehicle is permitted to use it.
- **9** Despite section 8, a Vehicle may cross a Highway restricted to another Vehicle class in order to enter or exit from it from an adjacent driveway or intersecting Highway.

School Bus Lights

A person must not activate the flashing red lights or stop arms of a school bus on a Highway with curbs and gutters.

Right Turing Bus

When a Red Deer Transit bus is signaling a right-hand turn, whether the bus is in motion or stopped, a person operating a Vehicle on the Highway must not overtake or pass on the right-hand side of the bus.

Tracked Vehicles

Without a permit from the City, a person must not operate a Vehicle or Trailer having metal spikes, lugs, cleats, skids, or bands projecting from the surface of the wheel, tire, or track, except for studded tires or tire chains, on a Highway.

Road Bans

A person must not operate a Vehicle on a Highway subject to a road ban if the weight of the carrying axle or axle group of the Vehicle exceeds the specified percentage axle weight imposed by a road ban sign.

Truck Routes

A person must not operate or park a Heavy Vehicle on a Highway unless the Highway is designated as a truck route or a permit is issued by the City Manager.

- Despite section 14, a Heavy Vehicle may travel, but not park, on a Highway not designated as a truck route where the operator can show the Heavy Vehicle travelled the most direct and practical route between a location and the nearest truck route and is:
 - (a) providing services, delivering goods, or collecting goods from a customer;
 - (b) traveling to or from the business premises of the Vehicle owner;
 - (c) moving a building pursuant to a valid and subsisting permit under this bylaw;
 - (d) traveling to or from non-residential premises for the servicing or repair of the Heavy Vehicle;
 - (e) removing a disabled Vehicle from a Highway;
 - (f) traveling to or from a hotel or motel;
 - (g) traveling to or from work performed on a Highway; or
 - (h) a Public Passenger Vehicle.

Over-dimensional Vehicles

- A person must not operate an Over-dimensional Vehicle on a Highway unless a permit is issued by the City.
- 17 A permit used to operate an Over-dimensional Vehicle must be:
 - (a) valid and subsisting;
 - (b) in the possession of a person operating the Over-dimensional Vehicle; and
 - (c) produced forthwith to a Peace Officer on demand.
- A person must not park an Over-dimensional Vehicle, including any load carried on the Vehicle, on a Highway.

Weight Restrictions

- 19 A person must not operate a Vehicle:
 - (a) on a bridge where such Vehicle, with or without load, exceeds the weight designated by a Traffic Control Device at or near the bridge as the maximum load permitted on such bridge; or
 - (b) on City of Red Deer Highways in an overloaded condition and contrary to the axle loadings as prescribed in the regulations under the *Traffic Safety Act*.

Height Restrictions

A person must not operate a Vehicle under a structure with a maximum height limit for clearance indicated by a Traffic Control Device if the Vehicle exceeds that limit.

Slow Moving Vehicles

A person must not operate a Slow Moving Vehicle on the following Highways between the hours of 7:00 am and 9:00 am or 3:30 pm and 6:00 pm, Monday to Friday inclusive, except statutory holidays:

- (a) 67 Street, from Pamely Avenue to 30 Avenue; and
- (b) 30 Avenue from 67 Street to 55 Street.

Off-Highway Vehicles

Other than a Peace Officer, City employee or agent of the City performing employment obligations, a person must not operate an Off-Highway Vehicle on a Highway.

Part III - Parking

Prohibited Parking and Stopping

- Unless required or permitted by this bylaw, by a Traffic Control Device or in compliance with the direction of a Peace Officer, a person must not allow a Vehicle to stop or park on any portion of a Highway:
 - (a) where prohibited by a Traffic Control Device;
 - (b) marked as a construction area by a Traffic Control Device, except when the person is performing employment obligations at that location;
 - (c) marked as a bus zone by a Traffic Control Device;
 - (d) adjacent to, or impeding access from, a doorway intended as a fire or emergency exit from a building;
 - (e) adjacent to, or impeding access from, an entrance to any fire hall or ambulance entranceway to any hospital;
 - (f) marked for use only by a particular class of Vehicle by a Traffic Control Device if the Vehicle is not a permitted class;
 - (g) marked as a Fire Lane by a Traffic Control Device;
 - (h) marked as a commercial Loading Zone by a Traffic Control Device, unless:
 - (i) the Vehicle is a Commercial Vehicle; and
 - (ii) the operator is actively engaged in loading or unloading of merchandise or other materials;
 - (i) marked as a Loading Zone by a Traffic Control Device, unless actively engaged in loading or unloading a Vehicle;
 - (j) on a Sidewalk or Boulevard, except if the Vehicle is an E-Scooter;
 - (k) on a crosswalk;
 - (l) within an intersection, other than immediately next to the curb in a "T" intersection;
 - (m) at an intersection nearer than 5 meters to the projection of the lateral curb line of the Highway at right angles to the direction of travel of Vehicle;
 - (n) within 5 metres of the approach to a stop sign or yield sign;
 - (o) within 5 metres of the point on the curb nearest any fire hydrant;
 - (p) within 1.5 metres of an access to a garage, private road or driveway;
 - (q) within 5 metres of the near side of a marked crosswalk;
 - (r) alongside or opposite any street excavation or obstruction when the stopping or parking would obstruct traffic;
 - (s) at any other place where a Traffic Control Device prohibits stopping or parking, during the times stopping or parking is so prohibited; or

- (t) on the Roadway side of a Vehicle parked or stopped at the curb of the edge of the Roadway.
- A person must not allow a Vehicle to park:
 - (a) in an Alley unless:
 - (i) permitted by a Traffic Control Device;
 - (ii) unloading or loading goods from a Commerical Vehicle and for less than 30 minutes;
 - (iii) unloading or loading goods from a passenger Vehicle and for less than 5 minutes; or
 - (iv) within Terrace Park, in those areas where parking is permitted as illustrated in Schedule "A";
 - (b) in any location identified as being for the use of persons with disabilities unless the Vehicle:
 - (i) displays a valid parking placard or license plate issued or recognized by the Registrar of Motor Vehicle Services; and
 - (ii) is being used for the transportation of a person with a disability;
 - (c) on a Highway in excess of a time limit specified for the location by a Traffic Control Device and, for the purpose of calculating parking time, the time limit does not reset unless the Vehicle is absent from the location for 12 hours;
 - (d) on a Highway in any area identified as a Short Term Parking stall when that zone is closed;
 - (e) obstructing passage on any Sidewalk, trail, bicycle path, or on a ramp or access designated to accommodate persons with mobility challenges; or
 - (f) on any portion of a Highway 12 hours after moveable signs are placed to suspend parking in the area.
- When a Violation Ticket is issued for parking in a time-limited stall, if a Vehicle exceeds the time limit for a second or subsequent time, a further offense is deemed to occur and a second or subsequent Violation Ticket may be issued.
- Section 24(c) does not apply on a statutory holiday, Sunday, or such other day excepted by the City Manager.

Parking Weight Restrictions

- A person must not park a Vehicle, or a Vehicle with a Trailer attached, weighing or registered with a gross Vehicle weight exceeding 4,500 kilograms, on a Highway in a location adjoining residential property except if it is a:
 - (a) Recreation Vehicle; or
 - (b) Commercial Vehicle with hazard warning lamps lit and loading or unloading goods.
- Absent evidence to the contrary, a school bus is presumed to have a gross Vehicle weight exceeding 4,500 kilograms.

Length and Trailer Restrictions

- A person must not angle park, or load or unload any public service Vehicle or Commercial Vehicle exceeding 6 metres in length on a Highway, except at locations designated by the City Manager either by a Traffic Control Device or in writing.
- A person must not park a Vehicle exceeding 8 metres in length, or a truck tractor unit, with or without a semi-trailer or Trailer attached, on a Highway in front of, across from, or adjacent to residential property, unless the Vehicle is:
 - (a) loading or unloading goods;
 - (b) is a Vehicle exceeding 8 meters because it has a Trailer attached that is being temporarily used for construction, demolition, or landscaping; or
 - (c) a Holiday Trailer or Recreation Vehicle.
- A person must not park an unattached Trailer on a Highway in front of, across from, or adjacent to residential property.

Marked Stalls

A Vehicle parked on a Highway in a parking stall marked by lines or otherwise must be parked entirely within the markings.

Parallel Parking

- 33 (I) When parallel parking a Vehicle on a Roadway, a person may only park a Vehicle
 - (a) With
 - (i) the sides of the Vehicle parallel to the curb or edge of the Roadway, and
 - (ii) the right wheels of the Vehicle not more than 500 mm from the right curb or edge of the Roadway,

or

- (b) in the case of a one-way Highway where parking on either side is permitted, with
 - (i) the sides of the Vehicle parallel to the curb or edge of the Roadway,
 - (ii) the wheels that are the closest to a curb or edge of the Roadway not more than 500 mm from that curb or edge, and
 - (iii) the Vehicle facing in the direction of travel authorized for the Highway.
- (2) Despite subsection (1), a person may park a motorcycle
 - (a) at an angle, other than perpendicular, to the curb or edge of the Roadway, and
 - (b) with
 - (i) a wheel of the motorcycle not more than 500 mm from the curb or edge of the Roadway, and
 - (ii) the motorcycle angled in the direction of travel authorized for the traffic lane that is adjacent to the lane on which the motorcycle is parked.

(3) Subsection (1) does not apply where angle parking is permitted or required.

Angle Parking

- **34** (I) When
 - (a) a sign indicates that angle parking is permitted or required, and
 - (b) parking guide lines are visible on the Roadway,
 - a person may only park a Vehicle with the Vehicle's sides between and parallel to any 2 of the guide lines and
 - (c) in the case of a Vehicle other than a motorcycle, with one front wheel not more than 500 mm from the curb or edge of the Roadway, or
 - (d) in the case of a motorcycle, with
 - (i) a wheel of the motorcycle not more than 500 mm from the curb or edge of the Roadway, and
 - (ii) the motorcycle angled in the direction of travel authorized for the traffic lane that is adjacent to the lane on which the motorcycle is parked.

(2) When

- (a) a sign indicated that angle parking is permitted or required, and
- (b) no parking guide lines are visible on the Roadway,
- a person may only park a Vehicle with the Vehicle's sides at an angle of between 30 and 60 degrees to the curb or edge of the Roadway, or
 - (c) in the case of a Vehicle other than a Motor Vehicle, with one front wheel not more than 500 mm from the curb or edge of the Roadway, or
 - (d) in the case of a motorcycle, with
 - (i) a wheel of the motorcycle not more than 500 mm from the curb or edge of the Roadway, and
 - (ii) the motorcycle angled in the direction of travel authorized for the traffic lane that is adjacent to the lane on which the motorcycle is parked.

Abandoned & Unattended Vehicles

- A person must not leave a Vehicle on a Highway in one location more than 72 consecutive hours.
- **36** A person must not allow a Vehicle to be parked and left unattended on a Highway:
 - (a) on a jack or a similar device; or
 - (b) with one or more wheels removed or not touching the ground.

Parking on Private Property

A person must not park a Vehicle on private property marked by a Traffic Control Device, erected by the owner, tenant, or agent of either, prohibiting parking and

- indicating the property is privately-owned, without first obtaining permission from a person in charge of the property.
- A person must not park a Vehicle in a parking lot on private land to which the public has access contrary to the terms, conditions, or prohibitions contained in a Traffic Control Device erected at the entrance or within the boundaries of the land by the owner, tenant, or agent of either and:
 - (a) a Vehicle cannot park in excess of 48 continuous hours without the express or implied consent of the owner, tenant, or agent of either; and
 - (b) a Vehicle parked on such site must not be used for living or sleeping accommodation.
- A person, other than a lessee, must not park in a leased parking stall without the express permission of the lessor.

Parking on City Property

- A person must not operate or park a Vehicle on a Boulevard, Park, Public Facility, or utility right of way, on land owned by the City, except in a parking lot or where permitted by a Traffic Control Device.
- A person must not park a Vehicle in a City parking lot or parkade for more than 48 consecutive hours.
- The City may remove and impound a Vehicle parked in a City parking lot or parkade for more than 48 consecutive hours.

Short-Term Parking

- When a person parks in Short Term Parking:
 - (a) payment is required for the time the Vehicle is present in a parking stall from 8:00 am to 4:30 pm, Monday to Friday, except statutory holidays;
 - (b) the Vehicle must not exceed the time restriction for the applicable zone or subzone;
 - (c) the Vehicle must be entirely within the parking stall markings; and
 - (d) the Vehicle must obey all terms, conditions, or prohibitions outlined in a Traffic Control Device erected at the entrance or within the boundaries of parking lot.

Monthly Parking

- When a person with a monthly parking permit parks a Vehicle in a City-owned parking lot, the person must:
 - (a) comply with the terms and conditions of the parking permit;
 - (b) only park in the designated stall to which the permit applies;
 - (c) the Vehicle must be entirely within the parking stall markings; and

(d) the Vehicle must obey all terms, conditions, or prohibitions outlined in a Traffic Control Device erected at the entrance or within the boundaries of parking lot.

Parking Regulations for Vehicles for Hire

- **45** A Vehicle for Hire:
 - (a) may only be parked in an area marked for use by Vehicles for Hire while loading or unloading and for a maximum of 10 minutes;
 - (b) may not park in any City lot or parkade to load or unload; and
 - (c) must not exceed 6 metres in length when parking in an angled parking stall on a Highway.

Holiday Trailers & Recreation Vehicles

- A Holiday Trailer parked on a Highway must be attached to a Vehicle by which it may be drawn.
- When attached to a Motor Vehicle, a Trailer or Holiday Trailer is deemed to be part of the Motor Vehicle.
- In a residential area, a person must not park a Recreation Vehicle or Holiday Trailer on a Highway immediately adjacent to, or directly in front of, a residence without the consent of the owner or occupant of that residence.
- 49 A Recreation Vehicle or Holiday Trailer must not be used for sleeping or living quarters on a Highway.

Residential Parking Program

- A person must not park a Vehicle in a RPP Zone marked as a "Parking by Permit only" other than a Vehicle displaying a valid residential parking permit.
- A person must not park a Vehicle in a RPP Zone for any period of time exceeding the time limit so designated other than a Vehicle displaying a valid residential parking permit.

Part IV - Sidewalks and Boulevards

Motor Vehicles on Sidewalks

A person must not operate or park a Motor Vehicle, other than an E-Scooter, on any Sidewalk, trail, pedestrian overpass, or bicycle path, on any Highway or public lands owned by the City.

Leisure Vehicles

- A person must not operate a Leisure Vehicle:
 - (a) on a Sidewalk where prohibited by a Traffic Control Device; or
 - (b) in any Transit Terminal or parkade.

- A person must not operate an E-Scooter on a Highway, except on a:
 - (a) designated bicycle lane;
 - (b) Sidewalk
 - (c) trail;
 - (d) bicycle path;
 - (e) Boulevard;
 - (f) crosswalk; or
 - (g) Alley.
- A person operating an E-Scooter must not use the E-Scooter to carry a passenger.
- A person less than 16 years old must not operate an E-Scooter.
- A person operating a Leisure Vehicle on a Highway, Sidewalk, trail, or bicycle path must:
 - (a) yield the right of way to slower moving people;
 - (b) alert anyone about to be overtaken by sounding a bell or calling out; and
 - (c) exercise due care and attention given the nature, condition and use of the Highway, Sidewalk, trail, or bicycle path, including consideration for other persons using the area being traveled.

Material on Highways

- **58** A person must not:
 - (a) place, or cause to be placed, any Hoarding, snow, ice, dirt, gravel, grass, leaves, materials, equipment or other obstructions, upon any Highway, other than snow from the immediately adjacent Sidewalk deposited in a manner that does not impede traffic, unless a permit is issued by the City Manager; or
 - (b) leave any Hoarding, snow, ice, dirt, gravel, grass, leaves, materials, equipment or other obstruction on a Highway after the expiry of a permit.

Snow and Ice Removal from Sidewalks

- A person must clear snow or ice from a Sidewalk adjacent to land the person owns or occupies within 48 hours of when it is deposited, unless a berm separates the land and Sidewalk.
- A person must not place, or cause to be placed, any salt on a Sidewalk or Roadway without authorization of the City Manager.

Lights and Signs

A person must not place, cause or permit to be placed a light, sign, or any object emitting or reflecting light so as to distract or interfere with the vision of persons operating Vehicles on a Highway.

- A person must not place, cause or permit to be placed a sign on a Highway unless a permit or other approval authorizing placement of the sign is issued by the City Manager.
- For the purpose of section 62, an individual or corporation referred to on a sign, whether directly or indirectly, is presumed to have placed the sign or caused or permitted the sign to be placed.
- Despite section 62, signs advertising a garage sale do not require a permit if:
 - (a) placed no more than 48 hours prior to the start of the garage sale;
 - (b) removed within 24 hours after the conclusion of the garage sale; and
 - (c) placed for no more than 72 consecutive hours.
- **65** A person must not place a sign on a Highway:
 - (a) obstructing or attached to a Traffic Control Device;
 - (b) with a position, shape, colour, format or illumination similar to a Traffic Control Device:
 - (c) presenting a hazard, obstructing, or posing danger to vehicular or pedestrian traffic;
 - (d) attached to or within 2 metres of a fire hydrant;
 - (e) that is lit or electrified;
 - (f) that is inflatable;
 - (g) supported by string, rope, metal guidewire or similar device to add stability to the freestanding structure;
 - (h) attached to or obstructing any traffic signal pole or street light;
 - (i) attached to any Red Deer Transit sign, sign pole or structure; or
 - (j) causing or posing a risk of damage to municipal property.
- A person must not park a Vehicle being displayed for sale or displaying advertising directing persons to a commercial premises on a Highway without a permit from the City Manager.

Loading and Unloading Goods

A person must not load or unload goods or merchandise across a Sidewalk or Boulevard to a place where loading and unloading facilities are provided.

Private Property Obstructions

- A person must not permit any tree, hedge, shrub, fence or any other structure on property the person owns or occupies to:
 - (a) obstruct a Traffic Control Device;
 - (b) obstruct an adjacent Boulevard;
 - (c) interfere with a public utility; or
 - (d) impair visibility required for safe traffic flow at any adjacent intersection.

- A person must ensure trees, hedges or shrubs growing on property the person owns or occupies are pruned so branches do not project:
 - (a) over a Sidewalk at an elevation of less than 2.25 metres; or
 - (b) over a Roadway, including Alley, at an elevation of less than 4.12 metres.

Boulevard Modifications

- 70 On a Boulevard, without authorization from the City Manager, a person must not:
 - (a) remove, damage or plant any tree, hedge, shrub or other plant;
 - (b) prune, cut, repair, or perform any other work on any tree hedge, shrub or other plant;
 - (c) place a surface, other than grass, except on a driveway or Sidewalk;
 - (d) modify the construction of the Boulevard;
 - (e) construct a driveway or Sidewalk; or
 - (f) move any house or other building across the Boulevard.

Part V - Activities on Highways

Obstructing Traffic

- A person must not operate or park a Vehicle on a Highway blocking, obstructing, impeding, or hindering traffic except where stopping is unavoidable due to mechanical failure of the Vehicle if the person promptly takes measures to remove the Vehicle from the Highway and the Vehicle is removed within 48 hours.
- **72** A person must not obstruct:
 - (a) a building entrance;
 - (b) a Highway;
 - (c) vehicular or pedestrian traffic; or
 - (d) a Special Event.
- Despite section 72, people may congregate or assemble to attend and listen to public speaking or a parade so long as the proceedings are peaceable, orderly, and sufficient space is left to allow access to buildings and free movement of the ordinary traffic on Highways.

Hitch Hiking

A person must not stand on or walk along a Highway for the purpose of soliciting a ride from the driver of a Vehicle.

Hitching a Ride

A person must not be pulled by a Motor Vehicle while on a sled, toboggan, skateboard, skis, or other conveyance.

Prohibited Crossings

76 A person must not cross a Highway where prohibited by a Traffic Control Device.

Windrow Removal

- A person must not remove snow Windrows using a motorized Vehicle without a permit from the City Manager.
- 78 Snow collected during Windrow removal must not be deposited on City property other than a designated snow-collection site.

Street Vending

A person must not sell, or display for sale, any goods or services on a Highway without a permit from the City Manager.

Special Events

- A person must not organize, hold, or participate in any Special Event, including parades, on a Highway unless a permit is issued by the City Manager.
- 81 Section 80 does not apply to a military or funeral procession.

Funeral Procession

- A person driving a Vehicle in a funeral procession, other than the lead Vehicle, may, during daytime hours, drive the Vehicle into an intersection without stopping if:
 - (a) the Vehicle's headlamps and hazard warning lamps are alight;
 - (b) the Vehicle is travelling immediately behind the Vehicle in front of it in the funeral procession so as to form a continuous line of traffic;
 - (c) the lead Vehicle in the funeral procession is showing a purple flashing light; and
 - (d) the passage into the intersection can be made in safety.

Construction

- A person must not modify, cause or permit the modification of a Highway's construction without a permit or other authorization from the City Manager.
- A person must not use any equipment or conduct work on or over a Highway without a permit issued by the City Manager.

Highway Damage

- A person must not damage a Highway or remove any earth, gravel, concrete, pavement, or other Highway appurtenance, or make any excavation within or under any Highway, without a permit from the City Manager.
- A person must not operate a Heavy Vehicle on or across any Sidewalk, except at a curb cut or approved crossing, without first planking the Sidewalk to ensure the Sidewalk is not damaged.

Right of Way

- A person must not build or place any permanent or temporary structure, or any portion of it, on a Highway without a permit or other authorization from the City Manager.
- No person is entitled to obtain Vehicle access to a lot or parcel of land from a Highway without the City Manager's approval.

Dangerous Goods

A person must not dump or spill, or cause or permit dumping or spilling, any dangerous goods for which placards are required by the Alberta *Dangerous Goods Transportation* and *Handling Act* and regulations, as amended, on any City lands or Highway.

Part VI - City Transit Terminal & Parkades

Loitering Within a Transit Terminal

A person must not enter or be present in a Transit Terminal or parkade outside its normal operating hours, other than Peace Officers, emergency personnel, municipal employees, or contractors with the express permission of the City Manager.

Walking Within a Transit Terminal

A person not in a Motor Vehicle, must not be present in a Transit Terminal or parkade area restricted to Motor Vehicles by a Traffic Control Device, unless the person is a Peace Officer, emergency personnel, a municipal employee, or a contractor with the express permission of the City Manager.

Animals Within a Transit Terminal

A person must not bring an animal into a Transit Terminal, unless the animal is a registered medical service animal, a police service animal, or another animal specifically authorized by the City Manager.

Vehicles Within a Transit Terminal

A person must not operate a Vehicle in a Transit Terminal or other property where the operation of Vehicles is restricted to Red Deer Transit bus use only.

Rules of Use

- A person in a Red Deer Transit bus, Transit Terminal, or parkade owned or operated by the City, must observe and obey any applicable Rules of Use.
- A Peace Officer, transit operator, or other person in charge of a City bus, Transit Terminal, or parkade may evict a person breaching the Rules of Use.

Part VII - Exemptions

96 Despite any other provision in this Bylaw:

- (a) Emergency Vehicles;
- (b) service Vehicles of public utilities including telecommunications, electric systems, and natural gas systems engaged in repair, maintenance, or inspection of the utility in emergency situations;
- (c) Vehicles engaged in Highway repair, maintenance, or inspection; or
- (d) towing service Vehicles;

may operate, park or stop as necessary to perform work.

Part VIII - Enforcement

Offence

- A person who breaches any section of this Bylaw is guilty of an offence and is liable on summary conviction to:
 - (a) a fine in the amount specified in Schedule "B" or twice that amount for a second or subsequent offence within a 12 month time period; or
 - (b) for any offence for which there is no penalty specified, to a penalty of not less than \$200 for the first offence, \$400 for the second offence, and \$600 for the third and subsequent offence, within a 12 month time period

and in default of payment of any penalty, to imprisonment for up to 6 months.

Municipal Tag

- A Municipal Tag may be issued to any person where there are reasonable and probable grounds to believe the person contravened a provision of this bylaw.
- 99 If a Municipal Tag is issued in respect of an offence the Municipal Tag must specify:
 - (a) the name of the person;
 - (b) the offence;
 - (c) the fine amount;
 - (d) that the fine amount must be paid within 14 days of the issuance of the Municipal tag; and
 - (e) any other information as may be required.
- Where a Municipal Tag is issued in respect of an offence, the person to whom the Municipal Tag is issued may, in lieu of being prosecuted for the offence, pay the fine specified within the time period indicated on the Municipal Tag.
- 101 Where a Municipal Tag is issued, the penalty may be reduced by \$35.00 if paid to the City of Red Deer within 10 days of the date of service of the tag and Payment of the reduced amount will be accepted by The City in full satisfaction of the tag.

Violation Ticket

- If a Municipal Tag is issued and the specified fine is not paid within the prescribed time, a Violation Ticket may be issued pursuant to the Provincial Offences Procedure Act.
- Despite section 101, a Violation Ticket may be immediately issued to a person where there are reasonable and probable grounds to believe the Person contravened a provision of this bylaw.
- **104** If a Violation Ticket is issued in respect of an offence, the Violation Ticket may:
 - (a) impose the specified penalty established by this bylaw for the offence and permit a person to make a voluntary payment; or
 - (b) require a person to appear in court without the alternative of making a voluntary payment.
- 105 A person who commits an offence and who wishes to plead guilty may:
 - (a) if a Violation Ticket has issued in respect of the offence; and
 - (b) if the Violation Ticket includes a specified penalty as established by this bylaw for the offence:

plead guilty to the offence by making a voluntary payment by submitting to a Clerk of the Provincial Court, on or before the initial appearance date indicated on the Violation Ticket, the specified penalty set out on the Violation Ticket.

Service

- If the Municipal Tag or Violation Ticket relates to an alleged parking violation, it may be served on a person:
 - (a) personally;
 - (b) by attaching it to the Vehicle in respect of which an offence is alleged to have been committed; or
 - (c) by mail to the address of the registered owner of the Vehicle.

Continuing Offence

In the case of an offence that is of a continuing nature, each day or part of a day on which it continues constitutes a separate offence.

Refusing to Stop for Peace Officer

- An operator of a Vehicle who, when directed by a Peace Officer, fails or refuses to stop:
 - (a) and permit the Vehicle to be inspected;
 - (b) and permit the weighing of a Vehicle; or
 - (c) the Vehicle in a suitable place designated by a Peace Officer pending removal of excess weight

is guilty of an offence.

Owner Liable

- The owner of a Vehicle involved in an offence under the bylaw is deemed to be the person responsible for the offence.
- Section 109 does not apply if the owner of the Vehicle satisfies the court that, at the time that the Vehicle was involved in the offence:
 - (a) in the case of a Vehicle that was in motion.
 - (i) the owner of the Vehicle was not driving the Vehicle, and
 - (ii) no other person was driving the Vehicle with the owner's expressed or implied consent,

or,

- (b) in the case of a Vehicle that was parked
 - (iii) the owner did not park the Vehicle, and
 - (iv) no other person parked the Vehicle with the owner's expressed or implied consent.
- The Owner of an E-Scooter involved in an offence under the bylaw is deemed to be the person responsible for the offence.
 - (a) For this section, owner includes any person or corporation issued a business license for E-Scooter operations; and
 - (b) This section does not apply if the owner of the E-Scooter satisfies the court, at the time that the Vehicle was involved in the offence, it was not operated or parked with the owner's express or implied consent.

Contravention Prior to Certificate

The granting of a certificate or permit to operate a public Vehicle is not a defense to any contravention occurring prior to the granting of the certificate or permit.

Document as Evidence

A document purporting to be signed by the City Manager must be admitted in evidence as *prima facie* proof of the facts stated therein without proof of the signature or official character of the person signing the certificate.

Certificate under Weights and Measures Act

In a prosecution under this bylaw a certificate purporting to be issued and signed by an inspector under the Weights and Measures Act, RSC 1985, c W-6, as amended, and regulations, and bearing a date not more than one year either before or after the date of the offence charged, must be admitted in evidence as prima facie proof of the facts stated in the certificate without proof of the signature or official character of the person signing the certificate.

Certificate of Peace Officer

- In a prosecution under this bylaw, a certificate purportedly signed by a Peace Officer stating:
 - (a) that the weight was measured on a portable scale;
 - (b) the gross weight of a public Vehicle and the load it carries;
 - (c) the gross axle weight transferred to the Roadway through any point or points of contact of the Vehicle with the Roadway; or
 - (d) that the operator of the Vehicle accepted the weight determined as being accurate

must be admitted in evidence as prima facie proof of the facts stated in the certificate without proof of the signature or official character of the person signing the certificate.

Bills of Lading

- A person must, when requested by a Peace Officer, produce for inspection the bills of lading showing the origin and destination of the trip and the description of the load.
- Particulars obtained by a Peace Officer from a bill of lading produced under section 116 and submitted by the Peace Officer in evidence in court is prima facie proof of the particulars it contains without proof of the signature or official capacity of the person signing the bills of lading.

Permits

- A person issued a permit pursuant to this bylaw and any person carrying out an activity otherwise regulated, restricted or prohibited by this bylaw pursuant to such permit, must comply with any terms or conditions forming part of the permit.
- A person must not make any false or misleading statement or provide any false or misleading information to obtain a permit pursuant to this bylaw.
- If any term or condition of a permit issued pursuant to this bylaw is contravened, or if a false or misleading statement or false or misleading information was provided to obtain the permit, the City Manager may immediately cancel the permit.
- **121** A permit expires at the end of the time specified in the permit.

Removal and Impound of Vehicles

- A Peace Officer is hereby authorized to removed or cause to be removed any Vehicle or Trailer:
 - (a) operated or parked in contravention of any provision of this bylaw; or
 - (b) where emergency conditions may require such removal from a Highway.
- A Vehicle parked on a Highway in contravention of this bylaw that is removed and stored in a suitable place designated by the City Manager, will remain until claimed by the owner or the owner's agent.

No impounded Vehicle will be released to its owner or an agent until the impounding and removal fees are paid.

During Snow Removal or Street Cleaning

The City may tow or remove a Vehicle parked in contravention of this bylaw from a street being cleaned, cleared or repaired and place the Vehicle on an adjacent street or other area designated by the City Manager.

Certified Copy of Record

A copy of a record of the City, certified by the City Manager as a true copy of the original, must be admitted in evidence as prima facie proof of the facts stated in the record without proof of the appointment or signature of the person signing it.

Part IX - General

Authority of City Manager

- 127 Without restricting any other power, duty or function granted by this bylaw the City Manager may:
 - (a) restrict a Highway, or portion of it, to a particular class of Vehicle;
 - (b) designate Highways as truck routes;
 - (c) establish the days and times of operation for Short-Term Parking stalls and monthly parking permits;
 - (i) designate any portion of a Highway as a Short-Term Parking stall and prescribe payment requirements and other restrictions for Vehicles parked in such stalls;
 - (ii) designate periods of time when a parking ban is in effect;
 - (d) designate certain parking locations for the exclusive use of persons with disabilities;
 - (e) designate crosswalks upon any Highway and cause same to be marked;
 - (f) designate where Traffic Control Devices are to be erected and for purposes of greater certainty, this includes Traffic Control Devices:
 - (i) restricting the speed of Vehicles;
 - (ii) designating an intersection or place on a Highway, as a place at which no left-hand turn or no right hand turn or both is to be made;
 - (iii) designating an intersection or place on a Highway, as a place at which only a left-hand turn or a right hand turn is to be made;
 - (g) designate any intersection or place on a Highway as a place where u-turns are prohibited;
 - (h) designate any Highway or portion of it for one-way traffic;
 - (i) designate any Roadway as one to be divided into traffic lanes;
 - (j) designate School Zones and Playground Zones;

- (k) designate any Highway or portion of it as public or Commercial Vehicle loading and unloading spaces for such time limits as appropriate;
- (I) designate transit bus zones and school bus loading or unloading zones;
- (m) designate portions of any Highway as no parking or no stopping as appropriate;
- (n) prohibit parking at any Short-Term Parking stall and direct that such meters be closed;
- (o) designate angle parking on any Highway or portion thereof as appropriate;
- (p) designate maximum loads for any bridge;
- (q) prohibit or restrict the movement of Vehicles from a private driveway onto a Highway or from a Highway onto a private driveway where such prohibition or restriction is in the public interest for the regulation of traffic;
- (r) designate portions of any Highway where the use of Leisure Vehicles is prohibited;
- (s) impose road bans restricting the maximum weight allowed on any Highway based on a percentage of axel carrying allowance and designate the period of time road bans are in effect;
- (t) designate portions of any Highway where a school bus is permitted to use flashing lights or a stop arm;
- (u) establish Rules of Use for City buses, Transit Terminals, and City-owned parking lots and parkades;
- (v) temporarily close any Highway, in whole or in part, for the purpose of repairs, maintenance or other valid reason or in the case of an emergency; and
- (w) delegate any powers, duties or functions under this bylaw to an employee of the City.
- 128 The City Manager is authorized to determine the terms, conditions, forms, fees and to issue or revoke permits for:
 - (a) Over-dimensional Vehicles;
 - (b) using any equipment or conducting work on or over a Highway;
 - (c) the temporary use or occupation of a portion of a Highway;
 - (d) Hoarding;
 - (e) Parking, including for RPP Zones; and
 - (f) Placing privately-owned signs on a Highway.

Violation of Permit Conditions

- **129** Any person who:
 - (a) fails to obtain a permit as required under this bylaw; or
 - (b) contravenes the conditions of any permit issued under this bylaw;

is guilty of an offence.

Severability

130 The invalidity of any provision of this bylaw does not affect the validity of the remainder.

PART X - Transitional Provisions

- Despite the repeal of Bylaw 3186/97, the provisions of Bylaw 3186/97 remain in full force and effect for the purposes of any traffic tags, offence tickets, or prosecutions pending or entered for contravention of Bylaw 3186/97 prior to third reading of this bylaw.
- Traffic Bylaw No. 3186/97 is hereby repealed.
- Any permits issued pursuant to Bylaw 3161/96 shall for all purposes be deemed to be issued by the City Manager under this bylaw and remain in full force and effect, unless expired by their terms.
- Use of Streets Bylaw No. 3161/96 is hereby repealed.
- Alberta Cities Transportation Partnership Grants Program Bylaw No. 3221/99 is hereby repealed.
