- a) A Use of Streets Permit being requested by _____ to allow for the use of private construction equipment to remove windrows by the means of a motorized vehicle.
- b) Approval is subject to the submission of the following documents and the following conditions:
 - I. The applicant to produce proof of liability insurance (\$2,000,000 per occurrence) that lists the City of Red Deer as Additional Insured, prior to the permit being used.
 - II. The use approved from October 1, 2023 to May 31, 2024.
 - III. The applicant to ensure that approved motorized equipment be used, per the Traffic Act (i.e no off-road vehicles).
 - IV. The applicant to remove snow and place on the private property they removed it from in front of, or deposit in an approved, City-run snow storage facility.
 - V. The applicant will not begin windrow removal activities in areas where City crews are carrying out their snow removal activities. Applicants should wait until crews have vacated the specific zone they were working in.
 - VI. The applicant to adhere to ALL City Bylaws, including the Use of Streets Bylaw.
 - VII. The applicant is responsible for any damage to public or private property.
