

HOW TO PAY YOUR TAX BILL

Through your Bank

Check with your financial institution to confirm their processing times to ensure your payment is received by the deadline of June 30.

By Mail

With TIP

Tax Instalment Plan

Avoid paying your taxes all at once and sign up for TIP. Your total bill will be divided into automatic monthly payments for the remainder of the year, and there are no penalties or fees to enroll.

To sign up, login to MyCity and select preauthorized withdrawals.

Property Taxes are due in full.

7% penalty is applied to outstanding balances.

(for customers not enrolled in TIP)

If you can't pay your tax bill by the deadline, pay as much as you can to minimize the amount of the penalty on your account.

2025 MUNICIPAL PROPERTY TAX Overview

City Council approved a 10.5% increase to the operating budget to maintain and support critical services and infrastructure. The final tax rate includes the 2025 provincial requisitions collected for education and seniors affordable housing.


What this means

Property owners not enrolled in TIP will see a larger than usual amount on their property tax bill, due by June 30.

TIP participants may notice an increase in their monthly payment amounts starting on June 30.

GETTING STARTED ON MyCity

With a MyCity profile, you can manage your City of Red Deer accounts online, any time.

1 Register for MyCity

REGISTER FOR TIP Tax Instalment Plan

Make paying property taxes easier and more convenient with TIP!

TIP divides your tax bill into monthly payments, and there are no fees or penalties to sign up.

- 1 Locate the Pre-authorized Withdrawals section
- 2 Click [Sign Up](#)
- 3 Complete the application
- 4 Check your email for a confirmation of your TIP enrolment

Register before June 15 to avoid paying your taxes in one lump sum.
