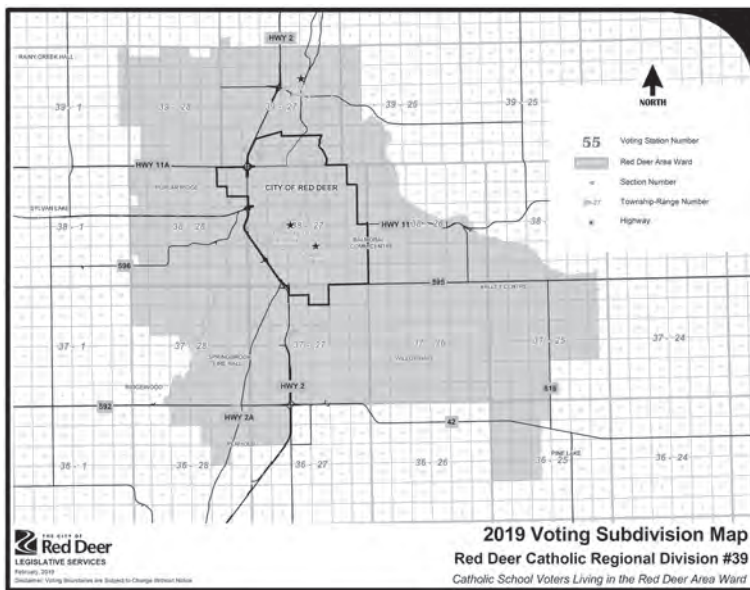

### ELIGIBILITY TO VOTE:

1. A list of voters is not prepared.
2. Every voter shall make a statement in the prescribed form that he/she is eligible to vote as an elector.
3. A person is eligible to vote if the person:
  - (a) is at least 18 years old,
  - (b) is a Canadian Citizen, and
  - (c) resides in Alberta and the person's place of residence is located in the Red Deer Catholic Regional Division #39 – Red Deer Area Ward on election day.
4. With regard to the election of Separate School Trustees an elector is an individual residing within the boundaries of the separate school district who is of the same faith as those who established the district.



### VOTER IDENTIFICATION:

You are required to **complete the oval** beside the name of the person for whom you wish to vote.
