NOTICE is hereby given that at its meeting to be held on **June 16, 2025, at 3:00 p.m.** The City of Red Deer Council and Red Deer County Council will hold a Joint Public Hearing for:

City of Red Deer Bylaw No. 3733/2025 and Red Deer County Bylaw No. 1008/2025, the City of Red Deer and Red Deer County Intermunicipal Development Plan to replace City of Red Deer Bylaw No. 3393/2007 and Red Deer County Bylaw No. 2007/29.
